NOTUS CITY ORDINANCE #463

AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2019 APPROPRIATING THE SUM OF \$942,994.00 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF NOTUS FOR SAID FISCAL YEAR, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY, AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

BE IT ORDAINED by the Mayor and City Council of the City of Notus, Canyon County Idaho.

Section 1: That the sum of \$942,994.00 be, and the same is hereby appropriated, to defray the necessary expenses and liabilities of the City of Notus, Canyon County, Idaho for the fiscal year beginning October 1, 2019.

Section 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

Section 5: This ordinance shall take effect and be in full force upon its passage, approval, and publication in one issue of the Idaho Press Tribune, the official newspaper of the City of Notus.
